A Bylaw to provide for entering into an agreement with the RM of Rosthern respecting the fire fighting services;

The Council of the Village of Laird, in the Province of Saskatchewan, enacts as follows;

1. The Village of Laird is hereby authorized to enter into the agreement attached hereto and forming part of this bylaw, and identified as "Exhibit A" with the following Municipality.

EXHIBIT "A"
FIRE PROTECTION AGREEMENT

Memorandum of Agreement made this 7 day of January, 2014.

BETWEEN: The Rural Municipality of Rosthern No. 403
 of Saskatchewan,
 (herein referred to as "Rosthern")

-AND-

The Village of Laird
of Saskatchewan,
(herein referred to as "Laird")

Whereas "Rosthern" may require fire fighting services for its residents in the Laird area and "Laird" hereby agrees to provide said services and parties hereby agree that:

1. "Laird" will provide a minimum of three (3) fully suited fire fighters from the Laird Volunteer Fire Department to answer fire calls in "Rosthern".
2. "Rosthern" hereby agrees to pay to "Laird" an annual grant of \$6,500.00 during the duration of this agreement.
3. "Rosthern" agrees to pay to "Laird" the following hourly rates for use of the equipment of the Village Volunteer Fire Department when called upon:

a) Fire Truck	\$650.00/hr
b) Tanker Truck	\$350.00/hr
c) Quick Response Truck	\$400.00/hr
4. That these rates shall be fixed for the life of the agreement.
5. That "Rosthern" shall make available fire fighting equipment owned by "Rosthern" stationed and manned by other municipalities for back up of the Laird Volunteer Fire Department should the need arise.
6. That "Laird" hereby agrees to pay fees to "Rosthern" as outlined by clause 3:
7. That all payments under this agreement shall be made within sixty (60) days of invoicing.
8. Maximum \$350.00 fee for false alarms for both trucks.
9. It is understood and agreed between the parties hereto that this agreement shall be for the years 2014, 2015, 2016 but either party may terminate this agreement upon six (6) months notice in writing.
